



OFFICIAL RULES

HOW TO ENTER

To enter, view www.d1nz.com for the official information and online entry form or email karen.malyon@gmail.com or megan.prime@yahoo.com. You must complete all information requested.

All contestants must submit two current photographs. Images should only include the contestant. All images submitted must be a head-and-shoulders shot and a full-length shot. Photographs shall become the property of MVP Media Ltd. By sending the above, the entrant thereby grants MVP Media Ltd the exclusive and universal right to reproduce that photograph and exploit any such reproductions in all media with respect to merchandising, advertising and/or publicity. All the personal information given to MVP Media Ltd will be treated as confidential.

Only one entry per person will be accepted; all subsequent entries will be disregarded. No altered photographs, or photographs containing more than one person, will be eligible. Any images exhibiting the contestant's nipples or genitals will be rejected.

ELIGIBILITY

All contestants must be female and must have been 18 years of age or older on the date that the earliest of the submitted images was taken.
